MISSION STATEMENT

OVERVIEW



The Oswego Fire Protection District has a rich history that spans over a century. The department's origins can be traced back to the devastating fire that destroyed the Congregational Church in Oswego in 1893. In response to this tragedy, the village purchased a hose and hose cart in 1895, and by August of the same year, a fire company was formed. A hose house was added to the town council house in June of 1897, and in 1898, a bell was placed in a tower atop the house to signal the firemen for a call.

The department continued to grow and evolve over the years, and in 1936, the Oswego Fire Protection District was formed by voter referendum, covering all of Oswego Township and part of Will County. Andrew Pierce, Glenn Leigh, James Steward, and Wally Davis were appointed the first commissioners.

In 1986, the district began providing full-time advanced life support emergency medical services in addition to the traditional fire suppression services. The district continued to expand, adding Station 2 in 1998, Station 3 in 2004, and Station 4 in 2006. The district also shifted from contract paramedic/firefighters to full-time sworn district employees in June of 2008, swearing-in 51 district-employed paramedic/firefighters.

Today, the Oswego Fire Protection District is a career department operating out of four stations. These stations are open 365 days a year, 24 hours a day, 7 days a week. The district covers 52 square miles of the northeast portion of Kendall County and about 4 square miles of mostly unincorporated industrial parks in northwest Will County, protecting most of the Village of Oswego, unincorporated Boulder Hill, a large portion of the south side of the Village of Montgomery, approximately 1 ½ square miles of the Grande Park neighborhood in the Village of Plainfield, and a small neighborhood in the far northeast area of the United City of Yorkville.

The district's population is estimated at approximately 75,000 residents and growing, in addition to the daily visitors and workers along the retail centers of Rt. 34, Rt. 30/Douglas, and Orchard Road. Over the years, the district has seen a steady increase in the number of calls for service, with 6,994 calls in 2024 alone.

In addition to providing emergency services, the Oswego Fire Protection District also offers various community services and specialty teams, such as Fire Prevention and Safety Programs, New Construction Plan Reviews, Annual Building Inspections, Fire Cause and Origin Investigation, Technical Rescue Team, Swift Water Rescue Team, Public Education Programs, C.P.R. Classes, Community Block Parties, School Visits and Station Tours, and Certified Child Passenger Safety Seat Technician Services. The district also provides classroom and live fire training facilities available to neighboring fire departments and Waubonsee Community College's fire science program.

The men and women of the Oswego Fire Protection District are committed to providing the highest quality of service and strive to challenge themselves to achieve the greatest potential for those they serve. The district's mission is to provide professional fire prevention, fire suppression, and emergency medical services while maintaining the confidence and respect of the community. Through exemplary conduct, the district aims to foster and enhance the realization that the Oswego Fire Protection District is an important requisite to the well-being of the entire community. The district's historic bell, once atop the hose house on Washington Street, now proudly displayed at the entrance of the Oswego Fire Protection District Central Fire Station on Woolley Road, serves as a constant reminder of the department's rich history and ongoing commitment to serving the community.



CHAPLAINS



In 2024 the Oswego Fire Protection District welcomed two new chaplains to help serve the emotional and spiritual support of our members.

Chaplains are available 24/7, including weekends and holidays, to offer counseling and comfort during times of crisis, such as the injury or death of a firefighter. They also assist with grief counseling, stress management, and other personal issues that firefighters may face. They also provide spiritual services during ceremonies. While rooted in religious traditions, fire chaplains can serve in a non-denominational capacity, respecting the diverse beliefs of the fire department members. Their presence helps create a supportive environment, ensuring that firefighters have the necessary resources to cope with the emotional demands of their challenging job.

INFORMATION TECHNOLOGY



In 2024, the Oswego Fire Protection District and Bristol-Kendall Fire Protection District hired Greg Thomas to be our IT administrator. His 40 hour work week is split between the two organizations. He has been working to bring advancements to the information technology and infrastructure for the fire district by modernizing and optimizing our hardware and software services. Over the past year, IT has been replacing our older infrastructure hardware making our servers capable of using the latest operating systems, security patches, and software versions. Additionally, many of our various software and service agreements have been reviewed to ensure that the district's requirements are being met. One accomplishment that has served the district well was setting up electronic payment options for contractors or citizens to pay any fees. The Information Technology department is committed to continue improving our systems and security in 2025 to ensure first responders can provide the highest level of service to our community.






In total, the Oswego Fire Protection District responded to a department record of 6,994 incidents in 2025. OFPD experienced a 4.73% increase to call volume.








Currently, the Oswego Fire Protection District is covered by four stations with three shifts (Red, Black, Gold) manning each station for twenty-four hours a day 365 days a year. Each shift works twenty-four hours on duty and forty-eight hours off duty. Medic 4 was added as a full-time staffed ambulance starting September 2024, to meet the service demand of ambulances.











After passing the Bond Referendum and fulfilling a promise to the community, a fourth staffed ambulance was added to Station #4. Previously, Engine 4 and Medic 4 were a jump company of three members. Effective September 8th, 2024 Medic 4 would be placed into full time service. Station 4 now houses 5 members a day 24/7. Additionally, Station 4 picked up additional responsibilities when the Grass Truck and Tender were moved from Station 1 to Station 4.



TRAINING







TRAINING







TRAINING



In December the Oswego Fire Protection District in coordination with Hearts in Motion hosted six Firefighters (Bomberos), from Guatemala, for three days of hands on training. Training topics covered self contained breathing apparatus (SCBA), fire behavior, forcible entry, search and rescue, vehicle extrication, firefighter rescue, and live fire exercises. The Bomberos that participated take the training back to Guatemala to train the firefighters in their country. The hearts in Motion program has played a critical role in bringing training to over 3,000 Bomberos Voluntarios GT (volunteer firefighters) since 1999.



HAZMAT



In 2022, the Oswego Fire Protection District (O.F.P.D.), part of MABAS Division 14, became an associate member of MABAS Division 15 HAZMAT, which is composed of 20 fire departments and fire protection districts. The O.F.P.D. currently has four members on the MABAS Division 15 HAZMAT Team, including three HAZMAT Technicians. These team members participate in monthly training sessions that include hands-on scenarios, tabletop exercises, and specialized instruction to ensure readiness for any hazardous materials incident.

In addition to the HAZMAT Team, all members of the Oswego Fire Protection District are certified at the HAZMAT Operations level through the Office of Illinois State Fire Marshall (O.F.S.M.) program. This certification allows every member to initiate and manage the early stages of a HAZMAT incident while the MABAS Division 15 HAZMAT Team is activated and deployed with specialized technicians and equipment to mitigate the situation.

The team continues to enhance its skills through participation in both training exercises and real-world incidents. In April 2024, two HAZMAT Technicians participated in a MABAS mock deployment drill held in North Aurora at the SKCTA. This drill provided an invaluable opportunity for team members to refine their skills in a collaborative environment with other regional HAZMAT teams.

The team also responded to a real-world incident on July 20, 2024, in Channahon, where they assisted in managing a HAZMAT situation involving Styrene. Engine 2, staffed with two HAZMAT Technicians and one HAZMAT Operations-certified firefighter, provided air monitoring and worked alongside plant employees to confirm the safe mitigation of the incident.

Through ongoing training, strategic equipment upgrades, and real-world experience, the Oswego Fire Protection District continues to strengthen its HAZMAT response capabilities, ensuring the safety and well-being of the community.



TECHNICAL RESCUE



Oswego Fire Protection District Technical Rescue Team had a busy year participating in training and responding to callouts with MABAS Division 15 TRT. The team members participated in a combined 190 hours of training in 2024. The team was called out to assist other agencies within the division three times in 2024. In one of those callouts, Oswego members assisted in successfully rescuing an individual from the top of a water tower in Channahon. TRT has a lot to look forward to next year. With the purchase of Paratech struts, TRT members can shore up a compromised structure, stabilize heavy vehicles, and provide better stabilization within a trench.

We look forward to 2025 and continuing to improve our Technical Rescue Team.

SWIFT WATER



The Division 14 Water Rescue Team has 13 active O.F.P.D. members with 6 additional members from surrounding Districts. Members participated in regularly scheduled drills consisting of boat operations, swift water swimming, and rope systems. The Division is currently a Type B deployable water team through IL-MABAS and seeking to become a Type A deployable by 2025. INVESTIGATIONS



2024 was another busy year for the OFPD Fire Investigators. Our team consists of 11 members who are certified as Illinois Office of the State Fire Marshal Fire Investigators, 2 certified Arson Investigators from the Oswego Police Department and as members of the MABAS Division 15 Investigation Team, we can request their assistance as needed. Within the boundaries of our district, 24 fires were investigated this year primarily consisting of vehicle or structure fires. In addition, MABAS Division 15 had 40 callouts that members were sent to when available. Team members attended over 75% of the monthly Division 15 training and we had 7 members recertify this year. Fire Investigators must obtain regular training and experience to maintain their certification. Moving forward into the new year, our goal is to expand our team and add additional members to the roster.

FIRE PREVENTION BUREAU



The Fire Marshal oversees the day-to-day operations of the Fire Prevention Bureau (FPB). This includes ensuring that the Fire District's codes and ordinances are up to date and relevant. Conducting occupancy inspections, new construction inspections, witnessing fire protection system acceptance tests and special inspections relating to code enforcement and fire protection system issues. The Fire Marshal reviews construction plans for fire and life safety code compliance and responds to FOIA requests about buildings and land. The Fire Marshal also assists with public information and community outreach through fire and life safety education presentations, press releases and social media updates. In the year 2024 the FPB completed the following:

- Conducted and participated in 69 Project Review Meetings
- Completed 16 Kitchen Hood Suppression System Plan Reviews & Acceptance Tests
- Completed 67 Fire Alarm Plan Reviews
- Completed 82 Sprinkler Plan Reviews
- Completed 43 Fire Alarm Acceptance Tests
- Completed 61 Sprinkler System Hydrostatic Tests
- Completed 1235 Final Safety Inspections including new or change of occupancies



BUREAU SUPPORT SERVICES



The Oswego Fire Protection District public education and community outreach programs have worked to reach, educate, and train the public on fire and life safety. Our members can be found at local community meetings, health fairs, and special events throughout the year. Our smoke / carbon monoxide detector program, car seat installation program, Knox Box program, CPR and AED programs are an effective means for establishing fire safety throughout the community. It also promotes an understanding and acceptance of regulations and technology that can improve safety within the homes, businesses, and institutions throughout the district. This year our support services completed the following:

- 32 car seat checks
- Hosted a car seat event
- Had 36 donors at our annual blood drive
- Over 1000 people attended our Open House
- Hosted OJPSA in conjunction with Oswego Police Department and had 20 participants
- Participated in National Night Out
- Participated in Chamber Hometown Expo, over 2000 people attended
- Attended several career fairs
- Attended multiple events as members of the Kendall County Triad
- Coordinated our annual Toys for Tots and collected



FLEET SERVICES

2024 was a busy year for Oswego Fire's Fleet Services. Over the past years, our organization has been incredibly fortunate to have firefighters with the training and skills to keep our apparatus available and responding to calls. We finally reached the time that bringing on a full-time mechanic was necessary. In May we welcomed Trent Walsh to the Organization as our first full-time mechanic.

In 2024 we saw three ambulances go back to the factory for chassis remounts. This has allowed us to refurbish ambulances at a fraction of the cost, and time, of getting a new one. For fire apparatus, lead times have not gotten any better, it is approximately three years once you order a new engine. With the bond money, we are in the process of obtaining a new truck, two new engines, and a new squad. We will be taking delivery of one of the engines in the summer of 2025. The truck is anticipated to arrive late fall 2026. The additional two apparatus will be in 2027.

Fleet services maintains our current apparatus, handles placing new apparatus in service, and maintains the training center. Our current inventory consists of: (6) ambulances, (5) engines, (2) ladder trucks, (2) boats, (14) staff vehicles, (9) miscellaneous vehicles as well as multiple generators and small tools.



Probationary members of the Oswego Fire Protection District are assigned a 12-month task book that must be completed during their first year of employment. In addition to the task book, daily evaluations are completed on each member. These evaluations cover fire and emergency medicine skillsets, teamwork, and station demeanor. After the completion of their probationary year, the candidate becomes a fully fledged firefighter/paramedic and is issued their official helmet shield and badge. We would like to congratulate FF/PM Ryan Bezely, FF/PM Walker Wells, and FF/PM Jesse Melow on completing their probationary year.



NEW HIRES



In 2024 the Oswego Fire Protection hired seven new probationary Firefighter / paramedics. Our probationary employees came to OFPD with Basic Operations Firefighter (240Hrs of training) along with their Paramedic License. They began a three-week orientation that includes EMS training, Self Contained Breathing Apparatus (SCBA), Engine and Truck Operations, Live Fire Training, and Mental Health Awareness. After Completion of their three weeks, they continue a one-year probationary period that includes completing a comprehensive probationary employee handbook along with daily and quarterly reviews.
